03/07/2019	The Scottish Government wants to make Scotland the best place in the world for BSL users (incl. Tactile BSL users) to live, work and visit. This means that people whose first or preferred language is BSL will be fully involved in daily and public life in Scotland, as active, healthy citizens, and will be able to make informed choices about every aspect of their lives.
	The Falkirk Plan will focus on people from Falkirk who use BSL/Tactile BSL and will take specific account of resources or lack of resources in the area. A collaborative approach has been adopted to allow the co-production of the plan. BSL users (incl. Tactile BSL users) have been involved in co-producing the plan along side partners from local council services, third sector and independent sector. For years 18/19 and 19/20, £16K has been awarded to Falkirk by Scottish Government in order to implement the plan.
	The BSL Plan for Falkirk, as required by BSL (Scotland) Act 2015. It sets out actions that Falkirk will take over the period 2018-2024. It follows the BSL National Plan 2017-2023, published 24 October 2017, which was developed through extensive engagement with D/deaf and Deafblind BSL users and those who work with them. The Falkirk plan is framed around the same long-term goals as BSL national plan. Falkirk Council have a commitment to supporting BSL, including in its tactile form.
	 The English version of the plan will be translated and period of consultation will take place for users of BSL/Tactile BSL. This will be through engagement events and social media. Falkirk Council are committed to continued engagement around a) implementing actions and b) providing feedback on
	progress. The plan will be reviewed annually and will contribute to national progress report in 2020. and will be a live working document.

If figures were held anywhere this would not be accurate information, as BSL users can also include people with hearing who use BSL to communicate with people who are Deaf.
